Minutes of the **PARISH COUNCIL MEETING** held on

*The meeting was adjourned*

*Strong concern was raised by a number of residents that the one and only bus service between Longton and New Longton is to be withdrawn in April next year due to the likely withdrawal of LCC subsidy. This has yet to be fully agreed by LCC full Council in February next year. LCC have also put forward proposals for individual parishes to run their own bus service. There is already a working group via LALC looking at a new bus service to Leyland from the Western Parishes. There might be an opportunity to extend its remit to include the potential loss of the 12/12A service. It was suggested by one resident that residents themselves might contribute in some way to maintain a service. It was further stated that this was yet another example of rural deprivation. It was suggested that the local MP should also be involved in any working group meeting. Residents were encouraged to write to their MP and also LCC itself. Concern was also raised that many people were unaware of the proposals. An agenda item is to be placed for the 2<sup>nd</sup> February 2015 to further discuss this matter at which LCC Cllr Fillis will be invited.*
