Minutes of **THE PARISH COUNCIL MEETING** held on

***It was resolved that the Minutes of the Meeting held on the 2<sup>nd</sup> February 2016 should be approved and signed by the Chairman as a true and accurate record***

30/16 To receive Declarations of Interest

31/16 To adjourn the meeting for a period of public discussion.

*The meeting was adjourned*

*It was suggested that in view of the LCC library closure plans that perhaps a joint letter of support for the retention of Longton Library by all Local Councils in the vicinity might be appropriate. It was further mentioned that Penwortham Town Council had put forward some suggestions that Longton Library remain open but that other elements of youth and child care might be located in Penwortham. It was further mentioned that a consultation on proposed closures would take place in May with decisions made in June of this year.*

*It was explained that there are to be 34 Service Provision Areas across Lancashire which will have a library, child care and youth facilities within each but that as yet no decisions could be made until an assessment of the buildings owned by LCC and currently used by them had been completed.*

*It was suggested that this Council might seek to obtain a copy of Penwortham Town Council's proposals which sounded an appropriate way of dealing with the situation in this Service Level Area – further discussion could then take place at a future Parish Council meeting.*

*The meeting was reconvened*

***It was resolved that the contract as produced by Preston Bus should be signed by the Chairman and Vice Chairman on behalf of this Council subject to an amendment as suggested by the Legal and Democratic Services Dept. of LCC who had looked at the proposed contract on behalf of this Council.***

*(The clerk will amend the contract as described in the response from LCC, arrange for it to be signed as above and forward to Preston Bus for their agreement and signature.)*

35/16 To consider the purchase and installation of two bus shelter benches for the bus shelter in Liverpool Road/Franklands and at a suitable (to be agreed) location in New Longton at a cost of £195 per bench and installation at £100 per bench by the suppliers (Ark Welding Chorley) or £150 per bench by SRBC; the costs to be funded from the recent CIL received by this Council.

***It was resolved that since SRBC were to refurbish the Liverpool Road/Franklands bus shelter there was no further action needed by this Council however in terms of New Longton it was resolved that a bench should be supplied by and installed by Ark Welding Chorley subject of course to permission from the bus shelter owner (SRBC)***

***St Andrews Church, Longton Methodist Church, Longton County Primary School, Madhatter's Tea Shop, The Rams Head, Meadowside Castle - Bed & Breakfast and Longton VM Sports & Social Club.***

#### ***NEW LONGTON***

***All Saints Church, New Longton Village Hall, Boundary Close Sheltered Accommodation, Children's Play Area Chapel Lane, New Longton Primary School, Stickyweeds Tea Shop and New Longton Cricket Ground***

37/16 To consider writing to Stagecoach to retain the 12A Monday to Saturday evening service (18.50H leaving Fishergate), Preston via Lower Penwortham, New Longton, Longton and other villages in the Western Parishes and eventually to Ormskirk by making it commercial since it is a busy service used for employment purposes to and from Preston and for leisure, mainly be paying passengers.

*It was resolved that this Council should not write to stagecoach as above but that it would be perhaps more appropriate to look at a later evening service from Preston when in future reviewing the arrangements entered into with Preston Bus as minuted at 33/16*
