A resident raised concerns over the state of a householder's garden. It transpired however that the property is situated in Little Hoole Parish and it was therefore suggested that he might contact them and the local SRBC Cllr for that area.

A resident asked whether the grass verges on Wham Lane could be cut more regularly – It was pointed out that LCC were responsible for verges and that it was thought that grass cutting next year would be increased from 2 cuts to 3 cuts per year as previously.

A resident enquired as to whether further bulb planting was to take place on the Wham Lane verges – it was suggested that she contact SRBC who were dealing with the matter.

A resident asked the Council to support the introduction of planters around New Longton – it was explained that her request had been put forward to SRBC, My Neighbourhood Forum who had asked whether this Council supported the suggestion – this was to be considered later in the meeting.
