

Any Other Business

It was mentioned that the Sports and social Club had with the agreement of the Secretary to the Trustee and Chairman cut back some leylandii trees which were restricting grass growth on the bowling green due to the blocking of the sun and the restricting of air flow across the green. The Tennis Club have made a verbal complaint that the action will encourage anti-social behaviour around their own cabin and that they should have been consulted with. The Secretary of the Trustee has asked them to put in writing their concerns which will then be considered.

It was also noted that the Tennis Club had advised the Secretary of the Trustee that they needed funds to relay the courts which were now in poor condition and that such work would cost more than £18K. They had requested financial support from the Trustee but had not clearly indicated how much they wanted or what other funding avenues were being pursued. The Secretary of the Trustee had advised them that the Trustee itself did not have funds to cover the whole but had on occasions in the past assisted the Sports and Social club with small amounts of pump funding to assist with their bids to larger funding organisations. He also suggested that they might like to speak to the Sports and Social Club generally about obtaining funding since they had been very successful in the past and might be able to suggest possible sources.

It was noted that no progress had yet been made regarding improvements to the overspill car park but that Cllr Coulton (SREC) was looking at the matter.

FAO Bill Whittle,

It is with deep regret we have no option to lodge a complaint against Longton Sports and Social Club.

The latest incident regarding the maintenance of the conifers has left us little option but to write to you in an official capacity.

Over the last few years we have worked with the club, agreeing to numerous improvements to the grounds and its facilities, some of which we have supported financially. To date we have maintained a good relationship with all parties.

A few weeks ago we were notified by email that the bowling club wished to trim the conifers alongside the bowling green and tennis courts to accommodate more light for the Bowling Green. After a couple of messages it was agreed they could be trimmed to a few feet above fence height.

Shortly after commencement of the work it was apparent that the conifers were not being trimmed, but cut down to stumps. Our committe member Chris Rodd contacted you and in turn I spoke with Frank Houghton and promises were made to stop this work. It did stop alongside the tennis courts but a little too late for our liking.

A few days later the whole of the conifers between the football pitch and the bowling green were cut down to stumps. We were never consulted about this work. This tree line provides value protection to our Chalet from the elements and vandalism. Our chalet and fencing are now exposed.

Should we now incur any weather damage or vandalism to our chalet or fencing we will be seeking reimbursement from the Sports and Social club. Our chalet and fencing have for many years been protected by these tree lines.

We would appreciate a response as too why we weren't contacted about the conifers behind the chalet and as to why those alongside the tennis court were cut down to trunks leaving no branches to protect our courts from the wind.
