

A resident mentioned continued problems with cigarette butts which were accumulating outside Porcinis Restaurant ostensible by their staff – a request is to be sent asking them to clean the area and/or provide a suitable receptacle in the interest of keeping the village tidy.

It was mentioned that the markings on the old Booths car park were worn – it was reiterated that this land was now in private ownership and whilst the owner had not stopped cars from parking, it was not a public car park and he had no requirement to mark it out as such.

It was mentioned that various lamp post around the Health Centre were in a poor state of repair – this is to be reported to LCC using their on-line reporting system so that they are aware of the issue raised.

It was mentioned that the footbridge over Longton Brook had been badly vandalised – this has already been reported to LCC PROW team.
