

The meeting was adjourned

A question was asked concerning the use of the Speed Indicator Devices across the area. It was noted that this was an agenda item to be discussed later however the Clerk explained that SRBC had now decided that they were no longer using these devices in the Borough.

It was mentioned that the planters at the front of the shops in Longton were not being maintained. The Clerk explained that this was being investigated since a local landscape gardener had taken responsibility for maintenance and clearly this had not happened this summer.

It was suggested that the war memorial at St Oswald' Church needed cleaning.

It was confirmed that this Council were to discuss a reduction in the number of its meetings.

The meeting was reconvened

74/18 To note and consider any action now that SRBC will no longer manage (and have not done so since October last year) our jointly owned SPID device since they are no longer using these devices anywhere across their area. This Council must now consider whether to wishes to undertake the putting up and taking down of the device across this parish area which involves 12 sites and which might be undertaken by our lengthsman who will require ladder training, the possibility of the purchase of a suitable ladder/platform, the taking of the device to the Clerks home so that the device can be altered using software so as to match with the speed of the site concerned and the recharging of the device between site locations.

It was proposed that this Council should take no action and effectively abandon the use of its SPID device.

A recorded vote was called – members voted as follows:

In favour of the motion: Cllrs Mather, Barnes, Riley, Welch, Artis, Alsop, Garside and Wignall

Against the motion: Cllrs Fox and Turner

Abstention: Cllr Gooch

It was therefore resolved that this Council should take no action and effectively abandon the use of its SPID device.

75/18 To consider the regularity of meetings:

You will understand many of our meetings are of short duration. Presently we hold 11 monthly meetings per year the exception being the month of August and these are normally held on the first Tuesday of each month except January when it is not practicable to do so since the agenda would have to be dealt with over Xmas and New Year and it is then held on the second Tuesday which means that the timescale between our January and February meeting is often only 3 weeks. I have looked at the agenda for February and March and feel that these could easily be combined into one meeting. My other three Councils only meet 8 times per year (on average every 6 weeks) and they have no difficulty in transacting business. Should any business arrive that cannot wait we have the option to call an extra ordinary meeting. My other Councils who only hold 8 meetings per year have only had to do this on a very few occasions in the last 10 years. I believe that we can operate just as effectively with fewer meetings and would suggest that as a minimum the January meeting is aborted.

It was resolved that this Council should reduce the number of its meetings to 8 per annum and that they should be evenly distributed at the existing locations in both Longton and New Longton with meetings taking place roughly every 6/7 weeks.
